**Aim of the study:** To find out employer's determination on employability skills of rehabilitation professionals.

**Methodology:** This is a quantitative type of cross sectional survey study where 25 samples were assigned purposively from different special need schools and rehabilitation organizations. Modified questionnaire was used for the study. Data was analyzed by using descriptive statistical analysis (SPSS= Statistical Package for the Social Sciences) method.

**Result:** Employability skills were important to the majority of the participants and they were satisfied on employability skills of rehabilitation professionals.

**Conclusion:** It is the duty both employers and graduates to make themselves concern about the need of each other. The graduates have to ensure themselves as quality full person to the employers of organization in job sector. In this situation, employers also play a vital role providing professional developmental training, assign supervisor in job sector for the better performance of graduates.
